Guest: Sandy Bristol, County Commissioner gave updates on county business including; she has learned what and what not to do at meetings. Gypsy moth traps can be purchased at the Conservation District for \$6 but should not be placed by Oaks. DO NOT to any cutting on oak trees from April 15 through fall. Commissioners approved the Sheriff Dept. request for a catwalk. Research is being done to buy or lease 2 vans for the Sheriff Dept. The budget workshop went well, commissioners and department heads went through goals and discussed problem issues. Both groups agreed that communication is extremely important and needs to be improved. Lori Ware is working on Harrison becoming designated as a Senior Friendly Community. **Tom House and Justin Pomerville** spoke about the upcoming school bond issue emphasizing safety and

security. Several people in attendance talked about the open concept and how difficult it was to deal with.
