Conway moved to approve the agenda, supported by Duby, All in favor. MC

Treasurer's report read by Duby, motion to approve by LaBoda, 2nd by Iutzi All in favor. **MC**

Reading of October minutes by LaBoda, motion to approve by Conway 2nd by Iutzi All in favor. **MC** LaBoda also read the resignation letter from Denise Goodenow from the Planning Commission and Zoning Board of Appeals. Applications will be accepted to fill these positions.

Invoices read by LaBoda motion to approve and pay bills including the Road Commission invoice by Duby, 2^{nd} by Conway All in favor. **MC**

Guest: Sandy Bristol, County Commissioner gave updates on county business including; there is a new Veterans Administrator and former administrator Haley will stay on the Veterans Park Board. Adult Day Care will be opening soon and a director has been hired. The Prosecutors Office received an innovative grant for \$360,000 over 3 years. Board okayed the Sheriff's office to have an office at MMCC for an officer. Sandy attended the open house at the high school and the comment was WOW! The city of Harrison and Hayes Township are looking for a blight officer.

Public Comments: Marty Johnson voiced concern over ongoing yard sales. Ray Pratt expressed concern over the condition of Mostetler Road between the bridge to Rodgers.

Linda Barkell, Planning Commission Secretary stated they met on October 9th and will meet on November 13th. They have been reviewing the Police Power Ordnance and will have a public hearing after final revisions.

Mark Janeczko, Zoning & Blight Enforcement stated he issued 5 new permits, sent letters for blight and is working on combines.

New Business: LaBoda read a brief article about the importance and compensation of Election Inspectors and asked the board to approve a raise. Conway moved to raise the pay of Election Inspectors from \$10 an hour to \$12 an hour, supported by Duby, all in favor. **MC**

Old Business: Conway reported that Hamilton Township Hall is now a certified Red Cross Shelter and explained that the Local Red Cross Director had resigned and that was the reason for the delay. He also reported that Emergency Management would like to improve communication between the fire department and law enforcement so responders can communicate more efficiently with each other during emergencies. The 911 Director is doing a great job and is working on getting Smart 911 which would help improve communication. Siren sounded on schedule.
