Call to Order at 6:00 PM by Melanie Conway for the Public Hearing for rezoning Sections 32 & 33 and the Pledge of Allegiance was recited.

**Approval of the Public Hearing agenda**: Motion by Mike Conway and 2 by LaBoda to approve the agenda as written. All in favor, M/C.

Melanie Conway explained the reason for rezoning Sections 32 & 33 to all present. This rezone was to change the Birch Hills Sportsman's Club setbacks to the covenant. Board discussion: Mike Conway discussed the setback changes and that the PC was advised that owners were all deeded access to the common area. All owners present agreed. There were 5 E mails received. Four had questions that were answered prior to the meeting and 1 E mail was from Todd Rachel stating he was in favor of the rezoning. Copies of all e mails are in the minute's cabinet. Comments from the audience: Charles Pardue stated he was not in favor nor against it but had concerns. He is concerned that people will impede on the back-property lines. He wanted to know if Mr. Whisler represented himself or the Birch Hills Sportsman's Club. PC advised him he represented the Club. Ron Vasich who lives next door to Mr. Pardue was equally concerned about changing the rear set back and would like to leave the zoning as is. Mark Janeczko explained the flow of Zoning Permits in Birch Hills and after discussion a motion was made by Mike Conway and 2 by McKee to table the rezoning.
