She was advised to take pictures of the animals on her property and contact Animal Control. George Laura, President of the Springwood Lake Home Owners Assoc had some concerns. Complaints of wash boarding, pots holes and dust on Springwood Lake Rd make it impossible for people to travel in and out of their properties and they would like to see the road paved.
